**VOTING RESULTS OF ANNUAL GENERAL MEETING
HELD ON 9 MAY 2017**

At the annual general meeting of the Company held on 9 May 2017, all proposed resolutions as set out in the notice of AGM dated 31 March 2017 have been duly passed by the shareholders of the Company.

At the annual general meeting of Man Yue Technology Holdings Limited (the “**Company**”) held on 9 May 2017 (the “**AGM**”), all votes on all the proposed resolutions as set out in the notice of AGM dated 31 March 2017 were taken by poll. As at 9 May 2017, the total number of issued shares of the Company entitling the holders to attend and vote for or against the resolutions at the AGM was 475,547,534 and there were no shares of the Company entitling the holder to attend and vote only against the resolutions or abstain from voting at the AGM.
