Aluminum electrolytic capacitors have wide application in many different fields. In addition to being used in electronic and telecommunication equipment, they can also be found in computer motherboards, monitors, DVDs, LCD television sets and flashlights for digital camera, etc. Able to provide high capacitance and high voltage, they are in growing demand worldwide.

To meet increasing sales orders, Man Yue has commenced expansion of its production plants in Wuxi and Dongguan. The new facilities added have helped to enhance the Group’s production capacity, efficiency and flexibility, allowing it to achieve greater cost-effectiveness. The Group’s production capacity increased significantly in 2005 totaling at 700 million pieces per month and is expected to continue to grow in the future.
